1. Agenda for the meeting. -- Approved

2. Minutes of the Nov. 22 meeting -- approved... no changes.

3. Treasurer's report: Bob Wehr --- Bank balance -- \$1,847.39... a 3 year high

III Recent deposit of \$685.00, representing 53 membership renewals.

4. Membership: WMCA sent 27 letters to 2021 members that had not renewed for 2022 --- 2 came back as having moved. As of 12/22/21, five (5) have renewed, and Bob expects more in the near future.

So far, the membership for 2022 is 122, representing 76 families.

Last year, 2021 membership was 124, representing 78 families..... stay tuned, as the member numbers will continue to rise.

The Bear Den Road letter mailing to 105 homes generated 30 memberships, a nice return so far of 28%. It was recommended that we do another mailing next year to a different section of the Worman's Mill community.

5. Liability Insurance for CH use is still \$300 with Erie Insurance, per BobW. All agreed to play the waiting game, as we have no idea as to when we can gain access to the CH, could be another year, and the liability issue may be different by then..... still some discussion on the matter.

6. Allan reported on the resident Heidi Sprout suggestion of on-line dues/donation portal thru the website -- could be a little complicated for our residents and also costs \$1.00 per transaction. It was decided not to persue it this year.
